Zacks+ SMA Portfolios

The Zacks portfolio team has constructed six distinct SMA portfolios around three main investment themes. These portfolios can tilt 60/40 or 40/60, depending on the client's investment goals.

Each portfolio:

- ➤ Is designed to function as a client's core allocation
- ➤ Is made up of a core portfolio and one no-fee, single-stock sleeve
- ➤ Maintains an average of 45–50 holdings
- > Can be funded with a minimum of \$100k

Zacks+ Core SMA

A diversified portfolio of large, mid- and small-cap companies that can help root a client's portfolio in a well-rounded all-cap allocation. This portfolio contains approximately 46 holdings (ETF and single stocks).





Zacks+ Equity Income SMA

A portfolio with a core allocation that provides exposure to companies with a consistent dividend history. This portfolio contains approximately 46 holdings (ETF and single stocks).





Zacks+Innovation SMA

A portfolio focused on a core allocation that offers exposure to a select number of companies investing in disruptive technology breakthroughs. This portfolio contains approximately 21 holdings (ETF and single stocks).
